Dear Colleagues,

It is our pleasure to share this second Annual Report for the Center for Health Policy and Research (CHPR). This annual report covers the academic year from July 1, 2000 through June 30, 2001.

This year there were 14 Center Associates who used CHPR as their base for research activities and 7 Center Affiliates who received salary support from research projects based in the Center. There were 15 funded research projects active this year (7 of which were new) with CHPR principal investigators. In addition, CHPR Center Associates were active on 14 other funded research projects. The Center Associates produced 43 peer-reviewed publications and made 33 presentations at national and international meetings.

CHPR hosted its first annual policy symposium this year. "Enhancing Patient Safety and Health in Iowa" brought together outstanding speakers from around the nation to take a critical look at issues, opportunities, and initiatives with respect to improving patient safety and health outcomes. We thank the Centers for Disease Control and the Center for Public Health Practice for providing support for this conference.

The Center supports the Department of Health Management and Policy doctoral program and offers weekly educational activities attended by faculty and Ph.D. students. In addition to 13 invited "Seminar Series" presentations, educational activities were expanded to include 8 "Journal Club" presentations and 7 "Research Updates" where Center Associates presented their ongoing research programs.

This has been a productive year for the Center for Health Policy and Research. As you will see from the project, publication, and presentation titles, the CHPR Associates and Affiliates are working on a number of significant health policy and research issues. We hope you find this report useful.

The Trial randomizes patients to either the conventional arm or the T cell depletion arm for comparison of results. The University of Iowa is the leader for the Health

Quality of Life Component of the Trial.
