

#### **MHA Program Update**

Greetings!

As I write this, we are anticipating the arrival of 24 new MHA students in about five weeks. Once again, we expect these individuals to be strong students and excellent ambassadors for the program and the Department.

Continuing on the ambassador theme, we anticipate that our 27 graduates this spring will

be excellent examples of the quality of preparation our students receive as they matriculate through the program. This quality is in no small part due to the contributions of alumni as mentors, guest lecturers, summer internship preceptors, and participants in the special events the Student Services Office organizes each year. We want to thank the alumni who participated in the MHA Speed Networking and Witt Kieffer events, admissions interviews, and mentoring throughout the year.

courses. In addition, we are creating a student-driven academic portfolio that will support students' selfassessment of their progress and academic advisor's ability to help students advance in these competency domains.

I trust you all are enjoying
the summer. The health policy
group within the Department has
kept itself busy since another
successful graduation in May. We
had two students leave us this last
spring. Nicole Westergaard was
accepted into the Carver College of

Medicine where she plans to use her

MPH in Policy degree to further her interests with community and population health. Katherine Read received this year's Barnes Award for her outstanding work and has accepted a fellowship position at St. Luke's in Cedar Rapids. Meanwhile, Aaron Horsfield is out in Washington DC completing his summer internship with the RUPRI Center. Mike Lightbody is completing his MPH practicum this summer from Kansas City. Aaron and Mike will be returning in the fall to complete their MPH in Policy degrees and will be joined by two incoming students, Nichole Brammer from Augustana College and Megan Neal from the University of Iowa.

We also are preparing to launch the Department's newest degree program, the MS in Health Policy. So far, we have accepted two students into the program. This new degree program complements the MHA and MPH degrees, by providing students with content knowledge and

methodological skills pertaining to the practice of health policy analysis and research. Students will acquire a range of skills that allow them to analyze and empirically evaluate policy content, formation, implementation, and outcomes. The vision of the Master of Science (MS) degree in Health Policy is to prepare graduates for policy analysis and research careers in a variety of settings including academic institutions, government agencies, private, non-profit, and other organizations explicitly involved with health policy where a combination of qualitative and quantitative methodological skills are sought.

Also, we're already starting to organize policy programs for the fall semester. After a successful first year launch, Chris Atchison will once again convene our seminar series in health policy, which features speakers who are working or conducting research in health policy, and offer seminar participants a ground level perspective on the most current issues. Please keep your eye out for those announcements. Also, on Wednesday, October 14, the University of Iowa Health Sciences Policy Council will convene the eighth annual Rebalancing Health Care in the Heartland. This year's conference will focus on "The Value of Healthcare" and will consider how health reform implementation is working toward supporting high-quality, low-cost health care delivery.

#### **Center for Healthcare Executive Studies and Services (CHESS)**

"CHESS" includes the Executive MHA Program (the Studies element of CHESS, see below update) and onsite management training of working professionals (the "Services" element). This summer, we have provided ten hours of onsite training to a total of 72 managers at two healthcare organizations. Workshop topics included General Healthcare Management Guideposts, Effective Business Communication Skills, and Best Practices for

Meeting Management. Other topics to be provided over the next year include Effective Process Improvement Tools, Basic Financial Management, Quality Improvement for Managers, and Managing Critical Communications.

#### **EMHA Program Update**

Eleven students are completing their first year in the new Executive MHA program, and twelve more are starting their studies this Fall semester. These 23 students bring a wide diversity of experiences and outlooks to the program, and include: seven physicians, eight hospital managers, four non-physician clinicians, three pharmacists, and a CFO. Slightly more than half are employed at UIHC, with four of the remaining from Unity Point.

We are carefully laying the groundwork for adding a Des Moines campus. Members of the third cohort (students starting August 2016) will have the option to

attend classes in Iowa City (at the College of Public Health) and/or in Des Moines (at the Pappajohn Education Center). The curriculum will continue to be in-class based, not online. Academic and practitioner faculty will still lead every class, and courses will continue to be held Tuesdays from 4:00 to 8:00 pm over the two-year curriculum.

#### Health Policy Group Update by Aaron Horsfield, 2nd year MPH

Greetings from our nation's capital! Amid the high humidity and copious sightseeing, I have had the privilege to intern with the Rural Policy Research Institute (RUPRI) as the National Policy Program Intern. RUPRI was founded in 1990 to address the concerns of members of the Senate Agricultural Committee regarding the lack of data, information, and analysis surrounding the impact of public policy on rural communities. The Institute focuses upon research, policy analysis and engagement, and dissemination and outreach in Health Policy, Poverty and Human Services, State Policy, and many other areas of work.

This summer, Jocelyn Richgels, Director of RUPRI's National Policy Programs, has served as my preceptor and mentor. She has been monumental in introducing me to the staffers on the Hill, has allowed me to attend Senate and House briefings not only related to rural, but to my own interests, and has welcomed me to a variety meetings with government and collaborative organization leaders. I've had the opportunity to work with leaders from many fields and meet individuals from all over the world. Outside of attending meetings and briefings, I have produced topic guides regarding Population Health and the Affordable Care Act and each respective topic's impact on the rural community for the Rural Assistance Center, completed a literature review surrounding food assistance while currently working on literature reviews for income assistance, early childhood education and child care, child welfare, and child poverty and am in the early stages of assessing state models and policies for Family Resource Centers. Additionally, I have worked with Teresa Kittridge,

RUPRI'S Vice President and COO, on developing content and editing language for the new website as well as coordinating a social media plan for the organization, and continued my work with Dr. Mueller surrounding individual state pursuits of Medicaid expansion.

I am thankful to have had the guidance of not only Jocelyn, but other University of Iowa and Health Management and Policy Alumni. Anything is possible in DC. Many people with an MPH in Health Policy or MHA background have jobs in various facets of the government, political, and organizational fields.

From the networking happy hours to joining the Society of Health Policy Young Professionals and the iClub of DC to the walking monument tours, they say once you have lived in D.C. it is extremely hard to leave. I am going to have a hard time leaving Washington, but I have a feeling I'll be back - someday.

#### First Year Class Trip — Chicago by Bryson Kruthoff, 2nd year MHA

As we reach the beginning of the end of our first year, working hard to complete our papers, projects, and presentations, we were permitted a brief respite in the form of a class trip to the city of Chicago. Similar to our first semester trips to Des Moines and Omaha, our visit was intended to provide context to our in-class topics and broaden our knowledge base as we transition into our summer internships. We were exposed to a broad range of health care institutions, allowing for a well-rounded learning environment and a great educational experience.

Our trip began Wednesday morning with a stop at the American Hospital Association (AHA) where we were able to learn and discuss the issues facing hospitals today and how the Association is helping members navigate various changes in the industry. We had the pleasure of interacting with George Bergstrom, who graduated from the program in 1974, and holds the position of Vice President for Member Relations. Membership with the AHA includes a diverse set of health care organizations that are affected differently by policy outcomes. It was interesting to learn how those involved with Member Relations are able to balance the interests of all members to ensure a harmonious relationship.

After the insightful discussion and delicious lunch provided by the AHA, we made our way across the river to the American Medical Association (AMA) for further health policy discussion. With the recent passage of a permanent fix to Medicare's Sustainable Growth Rate by the U.S. House of Representatives, we had the unique opportunity to learn about the lobbying efforts from the AMA as well as their initial reaction to the passage and what they believe will result from this fix. We were also allowed to ask questions and engage in discussion about how the AMA views the changes in the industry and how they are positioning themselves to best serve their members. Policy decisions set the ground rules for how we participate as health care professionals and learning the policy process early in our careers will be important for our future development.

Braving the rainy Chicago skies on Thursday morning, we made the short walk to the Rehab Institute of Chicago (RIC) to learn about the incorporation of post-acute services within the continuum of care was a great experience. Learning how the nation's top ranked post-acute care hospital is working to transition within our evolving industry. We were able to tour their facility and get a first-hand look at the incredible technology they utilize to treat severe injuries.

After parting ways with members of the RIC administration, we made a short walk over to Lurie Children's Hospital. Here we got the opportunity to speak with current and former fellows to gain a better understanding of how their fellowship is structured and how their application process works. After a short presentation, we were able to tour their facility, which opened in 2012. It was great to see how they were able to build and decorate the hospital in a way that created a more comfortable environment for the young patients.

To round out our Thursday, we visited Advocate Illinois Masonic Medical Center to learn about their hospital operations and how they manage the country's largest Accountable Care Organization (ACO). We were warmly greeted by Susan Nordstrom Lopez, President of Illinois Masonic, and Sheron Sherman, Administrator Financial Services, both graduates of our program. One of the highlights of this visit was our tour of their new outpatient facility, The Center for Advanced Care. Since the facility is not yet in operation — that is scheduled for April 27th — we had the unique opportunity to tour the entire facility including operating rooms, procedure rooms, doctor's lounges, etc. After the tour, Scott Kent and Matt Hendrick, two more graduates of our program, spoke with us about the operation of Advocate's accountable care organizations. Since the passage of the Affordable Care Act, ACOs have become one of the most popular topics in the industry. Learning how the largest ACO functions, how it has succeeded and how it can improve, was a great experience.

To finish off the trip, we made one final stop at John H. Stroger, Jr. Hospital, formerly known as Cook County Hospital. Serving the needs of their patient population, regardless of ability to pay, Stroger Hospital provided us great context and insight into a critically underserved area of our industry. Touring their world-renowned trauma center was the highlight of the visit. Learning about the immense pressure and limited amount of time allowed in decision making was truly eye-opening.

As we arrive back in Iowa City, continuing where we left off in our studies, we can be sure to draw from our experiences in Chicago to create a better learning experience in our classrooms and in our careers.

First-year students of the University of Iowa Master of Healthcare Administration program had the pleasure of having Shane Cerone and Chris Klitgaard, both alumni of the program, come help us improve our presentation and speaking skills.

After breakfast and an introductory session, Mr. Cerone and Mr. Klitgaard each took half the class for an interactive, hands-on workshop on presentation skills. #### Wehby and Colleagues Win Gates Foundation Grand Challenge Explorations Initiative

George Wehby will lead a project funded by the Bill and Melinda Gates Foundation to evaluate newborn metabolic biomarkers for their ability to predict gestational age and identify associations between them and long-term academic achievement.

The project will analyze existing data on gestational age, newborn metabolic profiles and academic tests from the population of children born in Iowa over the past three decades and will identify the most predictive biomarkers of gestational age and academic achievement. The investigators will also evaluate how much metabolic

markers explain differences in educational achievement by gestational age. In the future, they will expand their method to developing countries to help estimate gestational age and identify newborns at risk of neurodevelopmental impairments and poor academic achievement.

Other University of Iowa investigators and collaborators include Kelli Ryckman, assistant professor of epidemiology; the State Hygienic Laboratory at the University of Iowa; and Iowa Testing Programs, a research, development, and outreach unit in the University of Iowa College of Education.

## Study Looks at Complexity of Cancer Treatment Decisions

Despite advances in the treatment of many cancers, a number of patients choose not to be treated. In Iowa, more than 12% of those who learn they have cancer don't pursue treatment, according to research led by Marcia Ward in collaboration with Fred Ullrich and others.

The researchers originally were focused on identifying the location of cancer specialists across the state and whether there were gaps in patient access to cancer treatment. While analyzing data from the Iowa Cancer Registry, the team was surprised to find that so many Iowans did not pursue treatment within the first year after diagnosis.

Along with the expected factors of advanced age or advanced stage of cancer, rates of non-treatment were also higher in patients who visited non-accredited cancer facilities and those who saw physicians who were not cancer specialists. Individuals with certain types of cancers that are known to progress slowly were less likely to pursue treatment, including stage 2 prostate cancer and non-Hodgkin lymphoma. While distance to treatment facilities did not seem to be a factor, rural Iowans were less likely to choose treatment.
